Constellium Launches Notes Offering

Amsterdam, December 3, 2014 – Constellium N.V. (NYSE and NYSE Euronext: CSTM) (“Constellium” or the “Company”) today announced that the Company intends to offer, subject to market and other conditions, approximately €535 million of senior unsecured notes due 2023 (the “Notes”) consisting of U.S. dollar denominated senior unsecured notes and euro denominated senior unsecured notes (the “Offering”). The Notes will be guaranteed on a senior unsecured basis by certain of the Company’s subsidiaries.

The Company intends to use the proceeds from the Offering to finance the Company’s acquisition of Wise Metals Intermediate Holdings LLC (“Wise Metals”), pay related fees and expenses of the Offering and for general corporate purposes. There can be no assurance that the Company will successfully complete the Offering on the terms described herein or at all.

The Notes will be offered and sold to qualified institutional buyers in the United States pursuant to Rule 144A and outside the United States pursuant to Regulation S under the Securities Act of 1933.

The Notes have not been registered under the Securities Act of 1933 or any state securities laws and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements of the Securities Act of 1933 and applicable state laws.

This press release does not constitute an offer to sell or a solicitation of an offer to purchase the Notes or any other securities and does not constitute an offer, solicitation or sale in any state or jurisdiction in which such an offer, solicitation or sale would be unlawful.
